- 4. We may pass your name to our secure third party service providers like **sportyhq.com.**

Privacy & Cookies

Cookies are small text files which are stored on your computer when you visit certain web pages. At the JSRA we use cookies to understand how our site is used which, in turn, helps us to improve your overall online experience. Some of the cookies we use are necessary for the site to work whilst others are used to provide tailored advertising by trusted third parties. The different types of cookies we use

The JSRA uses the following categories of cookies on our website:

Strictly necessary – These cookies are essential for certain features of our websites to work, for example when you make payments for league registration. These cookies do not record identifiable personal information and we do not need your consent to place these cookies on your device. Without these cookies some services you have asked for cannot be provided.

Performance – These cookies are used to collect anonymous information about how you use our website. This information is used to help us improve our websites and understand how effective our adverts are. In some case we use trusted third parties to collect this information for us which may include recording your use of our websites but they only use the information for the purposes explained. By using our website, you agree that we can place these types of cookies on your device.

Functionality – These cookies are used to provide services or remember settings to enhance your visit - for example 'text size'. The information these cookies collect is anonymous and does not enable us to track your browsing activity on other websites. By using our website, you agree that we can place these types of cookies on your device.

Managing cookies – If you'd prefer to restrict, block or delete cookies from the JSRA or any other website, you can use your browser to do this. Each browser is different, so check the 'Help' menu of your particular browser to learn how to change your cookie preferences. If you choose to disable all cookies we cannot guarantee the performance of our website and some features may not work as expected.
